The conversion of the New Jersey Developmental Disabilities service and support delivery system from contract based reimbursement to fee for service reimbursement is well underway. Providers are billing for services and getting paid accordingly. However, there remains an important question in the minds of many: Is our documentation sufficient to withstand an audit from CMS?

This workshop will address the general requirements of documentation in a fee for service environment and how to support claims for payment with proper documentation. How compliance fits into a fee for service environment and how to integrate your compliance auditing and monitoring program into the billing process to ensure claims for payment are properly substantiated will also be addressed.
